On behalf of the Redevelopment Agency of the City of San Jose, we would like to inform you of the following material event(s) on the issue captioned above (the "Bonds"). The Bonds and all other issues insured by Syncora Guarantee Inc. (formerly known as XL Capital Assurance Inc.) and subsidiaries (collectively "Syncora") have had its insured ratings downgraded by the following rating agencies:

- On January 25, 2008, Fitch Ratings downgraded Syncora to 'AA' from 'AAA' with a "Rating Watch Negative."
- On February 7, 2008, Moody's Investor Services downgraded Syncora to 'A3' from 'AAA' and placed them on a "Negative Watchlist."
- On February 25, 2008, Standard & Poor's downgraded Syncora to 'A-' from 'AAA' and placed them on review for further downgrades.
- On March 26, 2008, Fitch Ratings downgraded Syncora to 'BB' from 'A' and placed them on a "Negative Outlook."
- On May 5, 2008, Fitch Ratings withdrew its 'BB' rating upon Syncora's request.
- On June 6, 2008, Standard & Poor's downgraded Syncora to 'BBB-' from 'A-' and placed them on a "Negative Credit Watch."
- On June 20, 2008, Moody's Investor Services downgraded Syncora to 'B2' from 'A3' and placed them on a "Negative Outlook."
- On October 24, 2008, Moody's Investor Services downgraded Syncora to 'Caa1' from 'B2' and placed them on a "Negative Outlook."
- On November 18, 2008, Standard & Poor's downgraded Syncora to 'B' from 'BBB-' and placed them on a "Developing Credit Watch."
- On January 29, 2009, Standard & Poor's downgraded Syncora to 'CC' from 'B' and placed them on a "Negative Outlook."
- On March 9, 2009, Moody's Investor Services downgraded Syncora to 'Ca' from 'Caa1' and placed them on a "Developing Outlook."
