The Agenda following this page contains a Consent Calendar section for routine business items requiring Redevelopment Agency approval, as well as general business items arranged corresponding to the Agency's Critical Service Areas. The Critical Service Areas represent the policy-making level for strategic planning, policy setting, and investment decisions in the critical functions the Agency provides to the community and to the City. The four Critical Service Areas are:

- ***Promote and Implement Neighborhood Improvement Strategies*** — Through collaboration, revitalize commercial and residential neighborhoods so they are livable, safe, diverse and economically sustainable.
- ***Enhance the Quality and Supply of the City's Housing Stock*** — Enhance the Quality and Supply of the City's Housing Stock
- ***Initiate and Facilitate Public Facilities and Spaces*** — To guide the creation of a fabric of public facilities and spaces that is useful, stable, inviting, delightful and instills pride in the community to foster the opportunity for other investments
- ***Initiate and Facilitate Private Development*** — Capitalize on market opportunities and facilitate private development in the fastest possible time with the highest quality customer service

You may provide input on agenda items by filling out a BLUE Speaker's Card and submitting it to the City Clerk or Agency's Clerk during the meeting. If you wish to speak to the Agency, some tips to help you are noted below:

- **Submit a speaker's card before the meeting and before the item is heard.** This will ensure that your name is called for the items you wish to address, and ensure the meeting runs smoothly for all participants.
- When the Board reaches your item on the agenda, the Chairperson will open the public hearing and call your name. Please address the Agency from the speaker's podium located to the left of the Clerk's table.
- Each speaker generally has two minutes to speak per item. The time allotted to speakers may vary at the Chairperson's discretion, depending on the number of speakers or the length of agenda.

5.1 Approval of an ENA with The Olson Company and Green Valley Corporation for a planned residential development.

Recommendations: Approval of an Exclusive Negotiations Agreement (ENA) with The Olson Company and Green Valley Corporation to negotiate for a 240-day period for a planned residential development on Agency-owned properties at 178 and 201 Bassett Street; 129, 149, 153, 160, 185, 188, 190 and 255 West Julian Street; 274, 276, 290, 331, 340 and 380 Terraine Street, and 181 Devine Street; 320, 328, 340, 345 and 353 North San Pedro; City property located under such roadways as may be vacated; and State of California property available for purchase located at 255 Bassett and 331 Terraine. 7 PRIVATE DEVELOPMENT

7.1 Actions related to the facility lease and Co-Sponsorship Operating Agreement for the San Jose Entrepreneur Center.

Recommendation:

- (a) Approval of a lease for the San Jose Entrepreneur Center (E-Center) with the Redevelopment Agency and San Jose State University Foundation (SJSUF) as lessees, and Ernest and Irene Pestana as lessors, for 16,350 square feet of office space at 84 West Santa Clara Street, for a one-year term, with two one-year extension options, with the Agency's contribution towards rent in an amount not to exceed \$224,000; and,
- (b) Approval of a Co-Sponsorship Operating Agreement between the Redevelopment Agency and SJSUF, which stipulate the financial obligations of the Agency and SJSUF in regard to lease payments and to designate the SJSUF as the fiscal agent for the E Center.

- 7.1 (c) Adoption of a resolution authorizing the Executive Director to negotiate and execute a Co-Sponsorship Operating Agreement or similar form of agreement between the Redevelopment Agency and the Small Business Administration that outlines SBA's relationship with the E-Center.
- (d) Approval for the addition of \$120,376 to the FY 2005-2006 Adopted Capital Budget project line Merged Area, Small Business Administration Lease and amending the FY 2005-2006 Agency appropriations resolution.

The Joint Redevelopment Agency Board convened at 2:44 p.m. to consider Items 8.1 and 8.2 in a Joint Session.

8.1 Approval of an ordinance deleting a portion of the Century Center Redevelopment Project Area.

Recommendation: Approval of an ordinance of the City of San Jose repealing Ordinance Nos. 26659 and 26660 to remove 31 acres bounded generally by Santa Clara Street to the south, Julian Street to the north, Third Street to the east and Market Street to the west from the Century Center Redevelopment Project Area and from the Merged Redevelopment Project Area. 8.2 Actions related to an agreement with San Jose Unified School District for Public Improvements at the Anne Darling Elementary School.

Recommendation:

- (a) Adoption of a resolution by the City Council making certain determinations required by law for Agency funding of a public improvement; and,
- (b) Approval of an agreement by the Redevelopment Agency Board with the San Jose Unified School District, in an amount not to exceed \$82,500, for Public Improvements at the Anne Darling Elementary School in the Five Wounds/Brookwood Terrace neighborhood, located within the Strong Neighborhoods Initiative Redevelopment Project Area.


